A lot of time and effort happens in large part because of a push from the outreach staff across the province.

- The Sweetheart Dinner was a tremendous success. Over 200 tickets sold, which was a sellout crowd. The Lucky You! draws went over very well and there was a lot of positive feedback.
- The Rotary Supplement will have a spread about the work that Lindsay is doing.
- The current Collective Agreement will end on March 31, 2014. Phil will be starting the process for negotiations soon and will update the board as there is news.

Phil circulated a press release on the Data Count which will go out on March 5th. March 8th is International Women's Day. The theme is *Inspiring Change*. There is also the local data and comments in the board packet. Bringing some of this to the Minister may be valuable. Nationally a lack of funding has been identified by shelters.

7. SAS House – Lauren McQuaid

Lauren McQuaid came to speak with the board about the changes with the board at SAS. Our board has set up a subcommittee to develop a plan to gather more information on the ways we could potentially become more involved. Unlike our Second Stage housing, SAS is long-term housing, which is a gap our clients currently face.

8. Second Stage Housing

There has been a recent trend in the shelter of young, pregnant women, typically under 25. A single woman often has difficulty accessing income support if her baby is unborn, as she is deemed to have no children.
