6. September 18th – Meeting with the Minister

Two years ago now we met with the Minister about a stable funding agreement between FVPS and the Provincial government. Phil would like to impress upon the minister that our funding is shrinking considering the rising costs of the organization- such as contractual obligations, HST changes, etc. Now currently we've gone from raising about 10% of our budget to more like 25% of our budget. We are now obligated to raise over \$160,000 in order to balance our budget. We would like to have some assurance from the Department that we wouldn't be penalized for raising excess dollars through efforts like social enterprise.

7. Management Letters

Bill presented the management letters from MRSB. This is a comment on the health of our record keeping. There were no major issues noted, just some minor items found during the audit.

8. Budget Analysis

Phil reviewed the budget analysis to August 31, 2014. The numbers showed our expenses to date with a projection for the remainder of the year. We are forecasting a small surplus for the year, which is good and we hope that it remains that way.

9. Metro Credit Union

We have historically dealt with TD bank for many of our accounts. We have also dealt with Metro Credit Union for some of our finances and they have been excellent supporters of our organization over the years. We had a meeting with them last week to discuss about shifting our accounts over to them. One major benefit is that we would save significantly on services charges.

10. ED Report

- The "Stop the Stigma" event was to take place on September 13th. This event has been postponed until March 2015.
- We are in the beginning planning process for Harmony House. Glenda Landry is going to be the honorary chair. Patricia Doiron is going to organize the event for a final year, this being the 5th year of the event. To date the event has raised over \$52,000 over the four years. It will be on November 15th.
- Posters for the choir event were circulated.
- The book project is going well and we have had a number of writing submissions.
- We have completed the change to take over the operation of SAS House.
- We are looking at ways to begin some social enterprise efforts to see what can be done to offset some
 of our costs
- We are in the process of updating our website and we will be presenting that soon.
- The 2014-2015 contract with the province has been signed. We received this in August.
- We will once again be running the Financial Campaign at Christmas this year. Our target is going to be \$25,000. Over the past two years we have raised about \$15,000 per year.
